(collectively, the "TPG Funds"), which, collectively, directly hold 76,583,599 shares of common stock (the "Common Stock") of Graphic Packaging Holding Company (the "Issuer"). Mr. MacDougall disclaims beneficial ownership of the shares of Common Stock that are or may be beneficially owned by the TPG Funds or any of their affiliates.
